

RESOLUTION NO. 013-21/22
Notification of Compliance with Education Code Section 60119 for the
2021-2022 Fiscal Year

WHEREAS, the governing board of the Livermore Valley Joint Unified School District in order to comply with the requirements of Education Code 60119 held a public hearing on October 5, 2021, at 7:00 p.m., which is on or before the eighth week of school (between the first day that students attend school and the eighth week from that day) and which did not take place during or immediately following school hours; and

WHEREAS, the governing board provided at least 10 days notice of the public hearing in at least three public places within our District that stated the time, place, and purpose of the hearing; and

WHEREAS, the governing board encouraged participation by parents/guardians, teachers, members of the community, and bargaining unit leaders in the public hearing; and

WHEREAS, information provided at the public hearing and to the governing board at the public meeting detailed the extent to which textbooks and instructional materials were provided to all students, including English learners, in our District; and

WHEREAS, the definition of “sufficient textbooks or instructional materials” means that each pupil, including English learners, has a standards-aligned textbook or instructional materials, or both, to use in class and to take home. However, it does not mean two copies of materials; and

WHEREAS, sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content and consistent with the cycles and content of the curriculum frameworks in the following subjects: English/Language Arts, History/Social Science, Science, and Mathematics; and

WHEREAS, the governing board has determined that each pupil enrolled in foreign language or health classes has sufficient instructional materials; and

WHEREAS, the governing board has determined the availability of laboratory science equipment as applicable to science laboratory courses offered in grades 9-12 inclusive; and

NOW THEREFORE, BE IT RESOLVED that for the 2021/2022 school year the Livermore Valley Joint Unified School District has provided each pupil with sufficient textbooks and instructional materials aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks.
