3.0 7:00 P.M. RECONVENE IN OPEN SESSION

3.1 The Regular Board Meeting was reconvened in Open Session by President Craig Bueno with Clerk Emily Prusso, Members Yanira Guzmán, Kristie Wang, and Anne White present.

President Bueno noted that District staff will continue to debrief following our Zoom Webinar Board meeting of the LVJUSD, with the intent to make modifications to the virtual meeting format if/as needed for future meetings. 6.0 STUDENT BOARD MEMBER REPORTS

Elise Davies - Granada High School, shared that this week was Homecoming Week! Traditionally, during Homecoming Week at Granada, each class would organize and put on a skit in the gym for the rest of the school to watch. This year, the theme was "Cities" and activities were modified so that the skits took place throughout the day. One day, the Freshman class decorated the entire campus to be "San Francisco" themed; there was even a Golden Gate Bridge model. Ms. Davies also shared that football games have been "Pink Outs" in honor of Breast Cancer Awareness Month. Football and Cheer Team uniforms all incorporated pink accents in order to raise awareness of everyone affected by breast cancer. Ms. Davies also noted that some students have failed to wear their mask properly indoors and reminded that masks are the best way to ensure the safety of everyone on campus. She closed her report by stating, "Remember to Stay Classy Granada."

Emily Wheeler - Livermore High School, shared that Livermore High School was in the midst of preparations for the *Finally Home* Homecoming Dance, scheduled to take place on Saturday, October 9th. The campus celebrated with themed dress-up days for every day of the week, including 'Freak out Friday' where students dressed in green and gold spirit wear. She wished luck to all of the sports teams playing throughout the week and weekend. Ms. Wheeler also remarked that they would hold

a "Club Rush," for the clubs to set up booths to advertise the clubs. She closed her report as she stated, "Today is a Great Day to be a Cowboy."

7.0 EMPLOYEE ASSOCIATIONS

Aimee Thompson, Livermore Education Association (LEA) President, reported teachers participated in a full day of conference-style professional development with a wide variety of workshop offerings on October 1st. She noted that elementary teachers were in the midst of goal setting conferences and high schools were hosting Homecoming activities. Ms. Thompson remarked that the LEA bargaining team will hold continued meetings around the bargaining table related to the 2021-2022 reopeners, and indicated that the first session was productive. Ms. Thompson also noted that the shortages of substitute teachers and paraprofessionals have had a major impact on education across the State. She concluded her remarks as she expressed thanks that everyone in LVJUSD is working together for the common focus of delivering the best for kids.

Ashley Bolduc offered her opinion that vaccination may not be the right choice for every family right now. She asked the Board to do anything that they can to allow parents the choice regarding whether or not to vaccinate their children.

Jackie Cota expressed displeasure with statements related to the COVID-19 pandemic and other comments made by Board members on social media and during a previous Board meeting.

Sydney Cushman shared reports that she believes include scientifically-backed ways that masks may cause potential harm.

8B Board Correspondence - The Board of Education received the following Formal Board Correspondence. Board President Bueno asked Clerk Emily Prusso to summarize the correspondence to the Board.

Jamie Blake (2), LVJUSD parent, expressed concern regarding equity grading and masking mandates. In addition, Ms. Blake posed questions regarding COVID-19 relief funds and vaccine requirements.

Rachel Gerlovich (2), LVJUSD parent, stated that the decision related to masks should be left to parents. In addition, she offered her opinion that parents should be welcomed to attend Board meetings in-person.

Mary Fake, LVJUSD parent, posed questions related to the protocols that keep the Board Room closed to parents and noted that parents want to feel heard. She also offered her opinion that vaccines should not be mandated. Ms. Fake also thanked District administration for being helpful and transparent in regard to a concern related to a classroom activity.

Sydney Cushman, LVJUSD parent, offered her opinion that following guidelines of the Centers for Disease Control (CDC) are unacceptable and without scientific proof.

Trina Wade, LVJUSD parent, posed a question related to the number of parents in support of or against mandatory masking and suggested the Board conduct a survey.

14.0 BOARD MEMBER REPORTS AND REQUESTS

Trustee Yanira Guzman reported that she was excited about upcoming events including goal setting conferences at the elementary schools, Homecoming and related events, and the Walk and Roll to School event.

Trustee Kristie Wang reported that she had recently attended the Quest Science Center Event at Stockmen's Park, the Special Board Workshop focusing on the Mathematics Teaching and Learning Plan, and the orientation for the Get SET, Girls in STEM Education program. She also reported that she has had some follow-up conversations with Math Teachers about some of the things discussed in the Special Board Workshop.

Trustee Anne White read a portion of the letter from Tomás Aragón, Director of the California Department of Public Health, indicating that the mask mandate carries the weight of law.

Trustee Emily Prusso reported that she attended the Livermore High School home football game, the Career Technical Education (CTE) Symposium, and the Special Board Workshop focused on the Mathematics Teaching and Learning Plan. She noted that she was very encouraged with the Mathematics Teaching and Learning Plan and remarked that LVJUSD is on the path to improve math achievement in our District. Trustee Prusso also shared that she was looking forward to Homecoming Events and all activities coming later in the week.

President Craig Bueno reported that he was pleased to see social interactions with students, full stadium stands during football games, and students enjoying themselves at sporting events. He continued by noting that these were signs of a return to some normalcy, while still in the midst of the

pandemic. President Bueno went on to express that while people are still suffering from COVID-19, the return to as much normalcy as possible has a direct benefit to students, and reminded that the adult concerns should be set aside to remember the focus on students. President Bueno remarked that LVJUSD is doing a great job keeping students and their needs at the forefront. President Bueno concluded his remarks as he asked for patience in the process and continued kindness toward teachers and staff.

15.0 SUPERINTENDENT'S REPORT

Dr. Bowers reported that Steven Martin had recently presented an overview of the YouthBuild program at the first Innovation Tri Valley (ITV) Education and Workforce Development meeting of the year. This spurred excitement, along with offers of partnership from throughout the region. Dr. Bowers continued by sharing that LVJUSD has challenged students to turn the negative social media Devious Licks challenge into a positive one. Students, staff, and LVJUSD families have been challenged to send an *Admirable Actions* photo, video clip, or brief quote and to "Post a Positive." These will be shared and publicized, demonstrating how LVJUSD students contribute to a positive school and community climate. Dr. Bowers also indicated that as an added incentive, entries will be submitted into a raffle for prizes. Some community partners have already contacted us to contribute funds for prizes.

Dr. Bowers also noted that staff participated in an all-day professional development conference in which offerings included mandatory training in English Language Development strategies. She commended the Curriculum and Educational Services Team for their planning and organization of the robust day of learning.

Dr. Bowers closed her remarks by stating, 'Be Well and Stay #LVJUSDstrong! We know we are #StrongerTogether!"
