## RESOLUTION NO. 008-21/22

## Establishing Gann Appropriation Limitations for 2020-21 and 2021-22

WHEREAS, in November 1979, the California electorate did adopt Proposition 4, commonly called the Gann Amendment; which added Article XIII-B to the California Constitution; and

WHEREAS, the provisions of that Article establish maximum appropriations limitations, commonly called "Gann Limits," for public agencies, including school districts; and

WHEREAS, the District must establish a revised Gann Limit for the 2020-21 fiscal year and a projected Gann Limit for the 2021-22 fiscal year in accordance with the provisions of Article XIII-B and applicable statutory law;

NOW, THEREFORE, BE IT RESOLVED that the Livermore Valley Joint Unified School District Board of Education does provide public notice that the attached calculations and documentation of the Gann Limits for the 2020-21 (\$99,768,625.45) and 2021-22 (\$105,485,367.69) fiscal years are made in accord with applicable constitutional and statutory law; and

BE IT FURTHER RESOLVED that the Livermore Valley Joint Unified School District Board of Education does hereby declare that the appropriations in the Budget for the 2020-21 and 2021-22 fiscal years do not exceed the limitations imposed by Proposition 4; and

BE IT FURTHER RESOLVED that the Superintendent provides copies of this resolution along with the appropriate attachments to interested citizens of this District.
