Subject: Parent Choice - Where there is risk - there must be a choice!

Dear Board Member -

Last school board meeting there was discussion in opposition of a number of bills that California legislators have proposed. Especially SB-871, which would require all children 0-17 to get the COVID-19 vaccine to attend child care or school. And SB-866 which allows kids 12-17 to get the COVID-19 vaccine without parental consent.

Even though you are not a California legislator, we did elect you to represent the people. I ask that you, our elected official, advocate against a vaccine mandate and for parental choice. Two things have been made abundantly clear to the public. One, these vaccines do not prevent the spread of COVID-19. Two, there is risk associated with these vaccines. And **where there is risk...there must be choice.**

More evidence has surfaced regarding the risks and catastrophic adverse events of these vaccines. Below is a link to documents which presents evidence of these adverse effects these shots are causing. Much of this data comes from the Defense Military Epidemiological Database, which is one of the best epidemiological databases in the world. There is evidence from Pfizer, and the FDA that these side effects were known before the shots were approved for emergency use authorization, and evidence that Pfizer and Moderna know these shots are gene therapy. This evidence has been presented to Senator Ron Johnson.

In addition, there is the VAERS data. As of March 4th, 2022, there have been 25,158 deaths associated with these vaccines. A reminder, the Swine Flu vaccine was pulled after 26 deaths in 2009. Again, there have been 25,158 deaths. Just to give you perspective, when you look at the number of deaths from all other vaccines since 1990, there have been only 9,592 deaths. We have had over 25,000 deaths from these shots alone since 2021. The number of life-threatening events...28,697. Number of hospitalizations...138,247. Adverse

reactions...1,168,894. Permanently disabled...46,515. How could one after reading and hearing this data, when there is clearly risk involved, think it is ok for a child to be forced to get this shot to receive an education?

Please read the below documents. I would appreciate a response from you at the next meeting in regards to this evidence. Many school districts in California have spoken out against this vaccine mandate. You can as well. It does not matter that this vaccine mandate may be implemented a few months from now or not until the Fall. The time to stop this is NOW!

Parents need you to advocate for the good of all not just a selective group - advocate for parent choice!
