#### 6.1 Student Board Members will report on their school activities

Amanda Dunmeyer - Granada High School (GHS) reported that Granada is in the midst of a flurry of exciting events for the month of September. GHS will celebrate Hispanic Heritage Month from September 15th - October 15th. GHS library staff have invited students in grades 10-12 to apply for the Library Advisory Board. Homecoming nominations opened the week of Sep. 7th, and Homecoming will be held at GHS on October 7th. Senior Information Night is September 20th. GHS students are encouraged to join the Cinema Club, where students watch films and discuss with friends how cinema has grown from past to present. Kudos to Chemistry teacher Amanda Cleveland and Math teacher Matthew Clifton, who were honored by the Pedrozzi Foundation for inspiring students. Congratulations to Computer Science Teacher of the Month, Kenon Willis. On September 7th, the JV Football team had an astronomical turnaround, winning their game against Castro Valley. On September 8th, the Varsity Football team won at home against Castro Valley. The teams are also sponsoring a fundraiser selling t-shirts, and 100% of the proceeds will go to support the Maui Firefighters. On September 15th, the Red, White & Blue game was held in honor of those who lost their lives on 9/11. The Girls' Flag Football team lost their first game, but look forward to learning from the experience. On September 15th, LHS hosted a Belly Flop Fiesta, won by the Senior Class representative. During Back to School (BTS) Night, it was exciting to see many posters hung around campus advertising upcoming activities, including Homecoming. Classes are busy planning their dances for Homecoming Skit, and it is fun to watch. BTS was a big success, with lots of parent participation. A recent Club Info Meeting has students excited for the official start to club activities. Seniors are preparing for the Senior Picnic. One of the Student Leadership groups is decorating a bulletin board for Hispanic Heritage Month. The theme for this year's yearbook is "Beyond What's Here." Stephanie Waggener, Classified School Employees Association (CSEA) President, thanked everyone who attended the Annual CSEA Potluck (held in May 2023) and supported fundraising efforts for annual scholarships awarded to members' students attending and/or planning to attend college. She reported that CSEA and the District have been working on negotiating a successor agreement for some time, and expressed disappointment that the salary increase (which CSEA did not negotiate) resulted in CSEA members not receiving specific concessions they requested. She shared that CSEA has been advised that, due to an anticipated \$6 million deficit next year, the District is not able to negotiate anything related to finances. She commented that, rather than close out selected student programs to reduce costs, the Board reversed course and retained those programs, and shared her opinion that if these difficult funding decisions are about the students, then perhaps the recent salary increases should not have occurred, although she is happy that CSEA members received a pay increase. She anticipates finalizing the successor agreement pending a few items currently being negotiated. CSEA is happy to report that, following the recent classification and compensation study, five (5) job classifications were identified as being below market value and have been reclassified to a higher range on the CSEA Salary Schedule.

#### **13.0 BOARD MEMBER REPORTS AND REQUESTS**

#### 14.1 Board Members reported on their activities and/or made requests to staff.

Trustee Emily Prusso reported that she attended Back to School (BTS) Night at Marylin Avenue Elementary School and was pleased to see the turnout. She was unable to attend Livermore High School's BTS Night, but heard that participation was strong there, as well. At a recent Tri-Valley ROP Board Meeting, Criminal Justice and EMR Instructor Austin Hudson was recognized for his contributions to the program. Trustee Prusso provided an update regarding ROP summer programs including Teacher Externship experiences, along with a series of free camps for ROP students hosted at Las Positas Community College. Topics included Girls Who Design and Construct, Robotics Manufacturing with participation and support from Tesla, and Drones; she noted that the camps were fully attended, but we need to encourage greater participation from our Livermore students next year. Trustee Prusso also attended the Lawrence Elementary Fun Run, and remarked that they raised a significant amount of money. She is a member of the Health & Wellness Committee, and shared that their latest meeting included a presentation by Child Nutrition Director Katie Crouse, discussions about policy changes regarding health and wellness, student mental health, and the continued emphasis by the Superintendent and Board to address mental health, bullying, and hate speech. Trustee Prusso believes that we are seeing anecdotal progress in these areas, and is anxious to see how the school year continues; she is hopeful that we can continue to improve student and teacher/staff relationships and mental health.

Trustee Kristie Wang reported that she recently attended the first middle school Cross Country meet of the season, as well as BTS Night at Joe Michell K-8 and Granada High Schools. The *Flavors Addict Kids Livermore* team attended BTS at Livermore High School, where they displayed vape related items confiscated from students in the first three weeks of this school year. She expressed appreciation for school administrators' willingness to display to parents/guardians the number of vape-related items on our campuses any given day. This continues to be an issue, and she encouraged people to talk with their kids about it. Trustee Wang participated in an All Schools Call hosted by the Alameda County Office of Education (ACOE) and Department of Public Health where they encouraged "community immunity" through COVID vaccines and flu shots. Ms. Wang attended the Tri-Valley SELPA meeting, where they discussed Special Education staffing, which continues to be a challenge across districts, and the use of creative staffing options such as consultants and internship programs. She appreciates Executive Director Frank Selvaggio for also trying to come up with creative ways to staff the program and looking ahead for long-term solutions to resolve the issue. Mr. Selvaggio and Special Education Coordinator Zandra Texeira will present the Annual State of Special Education on Sep 20th at 7pm presentation at the Livermore Library - Civic Center, and Special Education parents/guardians and students were encouraged to attend. Saturday, September 23rd is the start of the multicultural series at Bankhead Plaza, and Trustee Wang hopes to see everyone there.

Trustee Steven Drouin wished everyone a happy Hispanic Heritage Month. He reported that he attended the Youth Climate Summit on Saturday, September 9th, and noted that it was a fantastic event with engaging speakers and diverse booths. While the event was student-driven and targeted toward students, community members of all ages attended. Trustee Drouin attended a garden beautification event at one of our elementary schools and was wowed by the enthusiasm and dedication of the volunteers, and is appreciative of everyone helping out with the community gardens at our various schools. Mr. Drouin toured the SMART (Sheet Metal, Air, Rail, and Transportation) Local 104 training facility to learn about their training and career opportunities, which was a great way to learn about pathways in the trades. He is looking forward to the Green Strides tour at Altamont Creek Elementary on September 20th. October 4th is Walk & Roll to School Day, sponsored by the Alameda County Safe Routes to Schools (SR2S) Program to encourage families to safely walk and/or roll to school. Trustee Drouin and his child will ride their bikes to school that day.

Trustee Yanira Guzmán reported that she attended BTS Night at the middle and high schools. It was great to see so many families from diverse backgrounds attend and take part in their students' learning. On September 9th, she attended Junction Avenue K-8 School's 2nd annual Car Show hosted by their PTO, and it was an amazing event. Trustee Guzmán announced two upcoming community events: Saturday, September 23rd at Bankhead Plaza there will be a celebration of Indigenous Peoples and Hispanic Heritage Month. On Sunday, September 24th, Quest Science and the Bankhead Theatre will host a free screening of the film *A Million Miles Away*, the life story of astronaut José Hernández. Mr. Hernández has visited our schools and serves on the board of Quest Science Center, and will be in attendance to answer questions in both English and Spanish. The event is free but requires a ticket, so please obtain tickets from the Bankhead Theatre website (https://livermorearts.org/) She then repeated her report in Spanish. Trustee Guzmán hopes to see community members and families there.

President Craig Bueno reported that he also attended BTS Night and is looking forward to the Walk & Roll event. He acknowledged that there are a lot of good things going on in our schools, and appreciates the efforts in steering the improvements at Marylin Avenue and our MOF department projects. President Bueno noted that these are extraordinary tasks that require a lot of people behind the scenes.

#### **14.0 SUPERINTENDENT'S REPORT**

#### 15.1 The Superintendent reported on District activities.

Superintendent Van Schaack is happy to report that we are in the fifth week of the school year, and expectations have been set and routines established. He reiterated our District's renewed focus this year on creating and maintaining high expectations of student behavior, particularly as they relate to language, with a goal of eliminating profanity and hate speech from our schools. The Superintendent noted that we are also working to create school environments where appreciation and gratitude are regularly communicated. Fall sports are in full swing and we have already seen great performances by our student athletes. Superintendent Van Schaack announced that the District recently sent surveys to students and parents regarding the high school schedule and a move toward a semester-based system, which aligns with neighboring districts and provides students with opportunities to develop

connections with teachers over a longer period of time. After reviewing the information gathered, a decision will be made this fall. He shared that national and local dignitaries will visit Altamont Creek Elementary School (ACES) on September 20th (as part of the Green Strides tour) to observe their work with waste diversion and environmentally sound practices. ACES is among several of our schools recognized nationally for efforts to save energy and reduce waste. Superintendent Van Schaack thanked Lawrence Livermore National Laboratory (LLNL) for helping to provide instructional support for the Physics and Metal Shop programs at LHS. We have had great partnerships with LLNL and Sandia over the years, and our students continue to benefit from those partnerships. Lastly, the Superintendent has received emails requesting he thank the Board and Leadership Team for supporting their efforts to make classrooms inclusive and supportive learning environments for all students.
