4.0 CHANGES TO THE AGENDA

Dr. Bowers reported that there was one change to the agenda. We received two pieces of formal board correspondence prior to the deadline that were inadvertently left off the agenda. The correspondence was included in the Clerk's summary of correspondence for the Board.

5.0 RECOGNITIONS

5.1 Recognition of the Livermore Rodeo Princesses

Superintendent Bowers welcomed Michelle Dawson, Coordinator of Community Engagement, who recognized and honored the Livermore Rodeo Princesses: Daniella Johnson, Ivy Winters, Mia Martin, Brooklyn Kohistani, and Natalie Krauss. Ms. Dawson noted that in their roles as Rodeo princesses, these students make numerous public appearances and act as ambassadors, representatives, and liaisons for the Livermore Rodeo Foundation, Livermore Stockmen's Rodeo Association, and the City of Livermore. They were selected in part for their enthusiasm, communication skills, sportsmanship, and display of high morals and ethical character. Ms. Dawson remarked that we are pleased that these students are part of our LVJUSD community and know that the qualities and experiences they develop as Rodeo Princesses will make them great ambassadors for our District as well.

5.2 Recognition of Livermore Lab Foundation

Superintendent Bowers welcomed Michelle Dawson, Coordinator of Community Engagement, who recognized and honored Sally Allen of the Livermore Lab Foundation. Ms. Dawson recognized and thanked Ms. Allen and the Livermore Lab Foundation for their continuous and ongoing support of staff and students through education programs for teachers and students, internships, mentoring and donations of equipment and materials. Ms. Allen thanked Ms. Dawson for the opportunity to recognize three special Livermore High School Green Engineering Academy teachers: Karen Fletcher, Dorothy Morallos, and Joe Rodriguez, who enthusiastically agreed to take part in a Carbon Cleanup Initiative Education Pilot about the science behind carbon capture, mitigation, removal, and storage. Ms. Allen remarked that one of the most promising aspects of the Carbon Cleanup Initiative is the educational toolkit, designed with teachers and for teachers. This past year, the toolkit was piloted in 30 classrooms throughout California, three of which were by these Green Engineering Academy teachers at Livermore High School. This tool kit is the first of its kind in California, and likely the Nation. Karen Fletcher, Green Engineering Academy teacher, thanked the Livermore Lab Foundation and Lawrence Livermore National Laboratory for the opportunity to pilot this Educational toolkit. She stated that she, Dorothy and Joe were excited to be a part of the pilot program, as were their students, and they look forward to incorporating it into the future lessons and classes.

5.3 Recognition of Carl Melius Awardees

Chris Connor, Director of Elementary Education, had the pleasure of recognizing and honoring two outstanding District teachers who were awarded the Carl Melius Science Award for this school year. Dr.

Carl Melius is a Chemist at Sandia National Laboratories who has generously established an annual monetary award for excellence in teaching and integrating science curriculum in the non-science classroom. This year, teachers Debbie Smith from Sunset Elementary School and Mary Steeley of Joe Michell K-8 School were the recipients of this prestigious award.

Aimee Thompson, Livermore Education Association (LEA) President, reported that LEA had conducted an end-of-year survey of its members posing three questions, 'What were the greatest rewards?; What were the greatest challenges of the year?; and What is something that they are proud of this year?.' Ms. Thompson shared a sampling of survey results. Top rewards included: in-person instruction, working with colleagues, and student growth. The top challenges included: the need for academic and social emotional intervention, the shortage of substitutes, and COVID. There was a wide range of achievements that members felt proud of: successfully starting new programs, completing personal educational goals, volunteering at vaccination clinics, and contributing to and observing student growth and progress. Ms. Thompson closed her remarks by stating, "It is amazing what we can achieve when we work together for students."

Anne Brown, Community member, representing Tri-Valley Citizens' Climate Education and Livermore Advocates for Education, congratulated the Altamont Creek Green Team for their Green Ribbon Award. Ms. Brown remarked that these community partners desire to provide community support for the formation of a District Green Team that will create a coordinated approach to training, resources, and staff time. She urged the Board and District leadership to include Community partners when a District Green Team is formed.

Ms. Morrison thanked Dr. Bowers for everything she has done for children in our community as Superintendent for the last twelve years.
