Dr. Bowers noted that there was one change to the agenda relative to Discussion/Action Item 10.4. Copies of the corrected form were highlighted and provided to each Board member for reference and review.

She also noted that this was the first time in many meetings that no Formal Board Correspondence had been received after the agenda was published.

#### **5.0 RECOGNITIONS**

# 5.1 Recognition of Rancho Elementary School

Superintendent Bowers introduced Mr. Steve Martin, the proud principal of Rancho Elementary School, who recognized and honored a special group of Rancho Staff, known as the Rancho Rockstars. Those honored included: Cathy Finkbeiner, Intervention Specialist; Delia Ikeda, Intervention Specialist; Katrina Holden, Nurse; and Megan Sanborn, Library Media Specialist. Mr. Martin remarked that this team inspires and motivates him to be the best principal he can be. They rallied together to ensure the school office thrived in the absence of the regular office staff due to illness, through the January COVID-19 surge. Each one went the extra mile, with a positive mindset. Mr. Martin continued by stating that their efforts served as a reminder of the importance of finding humor, making time for students and staff, and building relationships - strategies guaranteed to motivate. Mr. Martin expressed his gratitude for each of them and their efforts to support him as well as Rancho Elementary School.

#### 5.2 Recognition of Junction Avenue K-8 School Office Staff

Superintendent Bowers introduced Mrs. Jeannette Garza, the very proud principal of Junction Avenue K-8 School, who accompanied by Vice Principals Donielle Machi and Jeremy Vilkins, recognized and honored several members of the Junction Avenue K-8 School Staff: Patricia De Santiago, Executive Assistant to the Principal; Mary Cruz Fernandez, Administrative Secretary; Mayra Garcia, Yard Duty Supervisor; Rocio Heredia, Instructional Specialist; Maricela Jimenez, Yard Duty Supervisor; and Sandra Rodriguez Morales, Office Specialist. Mrs. Garza commented that these staff members have a common goal, to serve the Junction community well. Their smiles radiate a genuine welcome. They are supportive, compassionate, and caring and are an integral part of the village that helps to guide, nurture and teach our community. Mrs. Garza remarked that all of women, new in their roles, didn't hesitate to jump in to support when needed; they distributed Chromebooks to nearly 1,000 students; assisted with meal service alongside Child Nutrition; provided assistance to students, parents, and

teachers with technology issues; and helped the school community navigate through many difficult and stressful days.

# 5.3 Recognition of Year 2 Teacher in the Tri-Valley Teacher Induction Program (TVTIP)

#### **6.0 STUDENT BOARD MEMBER REPORTS**

Emily Wheeler - Livermore High School (LHS), reported that Livermore High School Seniors are excited for the upcoming year-end activities. She noted that, based on Senior Family Surveys, the start time for the Graduation Ceremony has been adjusted to begin at 5:00 p.m. Ms. Wheeler congratulated Mr. Filice and Mr. Enright, along with band and orchestra students for their stunning success in the Festival Sweepstakes in Southern California. She also congratulated the Boys' and Girls' soccer teams that qualified for the Northern Coast Section (NCS) playoffs, and three LHS wrestlers that qualified for the State tournament. Ms. Wheeler remarked that the next several weeks are filled to the brim with exciting events for all Cowboys. She wished good luck to her fellow students on Advanced Placement exams and closed her report by stating, "Today is a great day to be a Cowboy."

Elise Davies - Granada High School (GHS), reported that students had celebrated several spring holidays recently (Ramadan, Passover, and Easter), and wished happy celebrations to those who celebrate. Ms. Davies noted several upcoming events that were filling the Spring calendar. She remarked that students could find specific information related to Advanced Placement (AP) and International Baccalaureate (IB) testing schedules on the school website and offered a reminder to seniors to apply for community service cords. Andres Sanchez, LVJUSD student, expressed opposition to teaching of sex and health education units. He shared his opinion that some of the anticipated content was inappropriate for students his age.

Mary Perner, Community member, expressed support for Measure A. She noted that Measure A will provide funding for science and technology specialist teachers and smaller class sizes. She urged all Livermore parents and grandparents to submit their ballots with a "Yes" vote.

Joanne Morrison, Community member, reviewed a portion of the text of Measure A that describes allowable expenses and the independent oversight. She expressed support for Measure A and urged all parents and grandparents to vote "Yes" on Measure A.

#### 14.0 BOARD MEMBER REPORTS AND REQUESTS

Trustee Wang reported that she had participated in the mock interviews with YouthBuild. She shared how impressed she was with the students and how well prepared they were. Trustee Wang noted there were several end-of-year activities coming up, and specifically highlighted the Spring Festival at Marylin Avenue on April 22nd and the Arroyo Seco Elementary School - World Cultural Celebration on April 29th. She encouraged all to submit their ballots and vote "Yes" on Measure A. Trustee Wang remarked that prior to being elected to serve on the Board of Education she had served on the Oversight Committee, which carefully scrutinizes expenditures to ensure that funds are spent appropriately. She noted that there would be one in-person voting location on May 3rd for anyone who preferred that voting option.

Trustee Guzmán reported that she had recently had a private tour of the Granada High School campus with Principal Matthew Hart. She remarked that her calendar is filling up and shared her excitement for year-end activities that are once again being held in-person. Trustee Guzmán offered a reminder to vote "Yes" on Measure A, and noted that she too had served on the Oversight Committee.

Trustee Prusso remarked that all should have received their ballot for the May 3rd election. She encouraged all to vote "Yes" on Measure A and commented that as a parent, all of her children have directly benefited from this parcel tax. She noted again that Measure A is a renewal and not a new tax. She also remarked that detailed Oversight Committee reports could be found on the District website. Trustee Prusso expressed appreciation for the strong support the Livermore community continually offers our schools.

Trustee White encouraged all to vote "Yes" on Measure A and encouraged all to participate in year-end activities, highlighting the Harlem Wizards fundraiser on April 28 - 29, 2022.

President Bueno, encouraged all to vote "Yes" on Measure A. He commented that these funds are a direct benefit to all LVJUSD students. He noted that the parcel tax is imperative based upon structural State funding deficits and noted that we have had remarkable success with programs supported by the parcel tax since 2004. He also commented that there are many year-end events to look forward to, specifically calling attention to the Harlem Wizards games on April 28th and 29th, which are the largest fundraising events of the year for the Livermore Valley Educational Foundation that so generously supports our schools. President Bueno closed his remarks by expressing appreciation for the strong support our community offers LVJUSD schools.

#### 15.0 SUPERINTENDENT'S REPORT

Dr. Bowers reported that she had a delightful day with Youth in Government, in which three students shadowed Board President Bueno and Superintendent Bowers. The students were introduced at City Hall and then visited our LVJUSD District Office, where they were greeted with goody bags, and had the opportunity to visit and learn from each Cabinet member and Department. Leaders of our partner

agencies, the City and Livermore Area Recreation and Park District (LARPD), were very impressed by the caliber of our student leaders from Del Valle, Vineyard, Granada, and Livermore High.

Superintendent Bowers also reported that she had co-emceed the Festival of Orchestras with principal Matthew Hart, in which orchestra students from across our District performed. She noted that her favorite part was when the combined middle school orchestras wowed the audience with their performance. The award-winning Livermore High School orchestra was particularly outstanding, and it was announced that they have been invited to perform at Carnegie Hall next year, based on their first place standings in a Southern California competition earlier in the month.

Dr. Bowers also commented that she had attended the Egg Drop at Lawrence and the mock interview process with the YouthBuild program. She remarked that students had the opportunity to prepare for interviews and future jobs in an exciting and not so traditional format. Students received real-time feedback and immediately incorporated suggestions into a subsequent interview. The students were polished, professional, and confident in ways they had not been when they first registered for the program.

Superintendent Bowers also reported that she had met with Congressman Swalwell's office regarding the LatinX Family Engagement Program and had the opportunity to pitch ideas for expanding wellness centers to all secondary schools and to enhance our Ag Science Pathway.

Dr. Bowers called attention to three meaningful resolutions passed by the Board earlier in the meeting, Resolution No. 045-21/22, recognizing all District employees, at every level and every site, as they continually rise to every challenge and go above and beyond to do whatever it takes for the young people entrusted to us. In addition, Resolution No. 046-21/22, recognizing our many volunteers - parents, industry and civic leaders and mentors who do so much for our students and schools and help us build community. She highlighted our Parent Club Information Council, as they serve as a liaison to each parent group and stated that their countless contributions are priceless. And, finally, Resolution Nos. 50-21/22 through 106-21/22, recognizing our retirees for their many years of service and devotion to our students, school, and community. She remarked their combined years of service total 1,376.
