6.0 STUDENT BOARD MEMBERS REPORT

6.1 Student Board Member Representatives will report on their school activities

Kathryn Johnson, Livermore High School (LHS) Student Representative, shared her school update.

Before going off to Spring Break, the Juniors completed their CAASPP testing. Since coming back to school from the Break, they have already had a lot of events, and are looking forward to many more coming up.

On April 11, the College and Career Center held a Summer Opportunities Fair where local organizations came during lunch in the quad to share internships, community service, and enrichment opportunities available to LHS students.

Congratulations are in order for their GravitechX Robotics Team! The team had their best competition to date on March 13 to 16 at the First Robotics Sacramento Regional Competition. The team ranked 6th out of 38 teams in the qualifying matches and was the second pick for the 3rd alliance. They made it to the semi-finals this year, and had twenty-six students attend along with club advisor Karen Fletcher, mentors, and parents.

LHS band, orchestra, and choir students performed at The Worldstrides National Music Festival where they swept the festival with multiple gold awards. Kudos are deserved for Mr Enright, the Band Director, and Mr. Lodge, the choir director.

On Saturday, the South Asian Students Association hosted their Spring event, Desi Dhamaka. The event had dancing, games, and food that celebrated South Asian culture.

In sports news, this year they will be hosting the Special Olympics. Swim hosted their first swim meet at Livermore High in 15 years in the new aquatic center. The Boys and Girls Lacrosse teams are playing well, and they had a victory in Boys Lacrosse on Tuesday night. Boys tennis has had a solid start including an EBAL win over De La Salle 6-3. As always, the Softball and Baseball teams are playing strong, Softball had a big 6-4 win over our Granada rivals recently. Last Thursday, Boys Volleyball had a very close game, but it unfortunately did not end in our favor. We will not let this stop us, and I know the next game Volleyball can bring it back. Their LHS Club Ice Hockey team has been playing in games for the last couple of weeks.

In upcoming news, the Annual FFA Tri Tip Drive Thru BBQ will take place on April 17th. This is their biggest fundraiser and getting support is vital to help students offset costs for the Fair competitions and assist with purchasing supplies and equipment.

She shared that this week is Greek Week. Greek Week is a friendly competition between the graduating classes to see who is on top. She is looking forward to getting to lead the rally on Friday. Their Spirit Days are Monday - Jersey Day, Tuesday - College Life, Wednesday - Tropical Day or Tacky Tourist, Thursday - Dress Like Your Bitmoji, Friday - Greek Week Class Colors, so Freshmen are blue, Sophomores are orange, Juniors are green, and Seniors are pink.

Six students have been nominated as their Olymian Finalists: Savannah Battion, Jae Cosgriff, Anne Polaski, Aiden Chirica, Nathan Thompson, Xavier Thorpe. These scholar athletes will find out on Monday, May 13th if they have won.

She shared that the Positive Behavior Interventions and Support (PBIS) theme for April centers around respect. Students in the Principal's Advisory Committee felt healthy relationships and social boundaries should be an area of focus around this theme. As a result, students in the Boundary Builders committee created lessons on healthy relationships, boundaries and consent. These lessons are being highlighted on CBNN, and via posters around campus as we lead up to our dances and other end of year activities.

She closed by stating, 'Thanks for listening, STAY COUNTRY and today is a great day to be a Cowboy!'

They just recently completed their first week of trimester 3, so they made it past the syllabus week, and are going to start getting into the swing of regular classroom instruction.

To throw a wrench in the regular classroom instruction, next week is CAASPP testing, so juniors will be coming in at normal time, and everyone else will be coming to school at 10:30am.

Applications for the Livermore-Granada Boosters Olympian Scholarship just closed, and senior athletes had the ability to apply for one of 12 Olympian scholarships. She cannot wait to see who is awarded!

She recognized their sports, who are doing very well in their seasons. She gave a shout out to softball, who is 4-1, boys lacrosse who is 6-1, and boys volleyball who just won a game on Thursday.

She congratulated Eric Hendrickson for being named the Rinetti & Co Realtors Teacher of the Month of February! She also congratulated Coach Wade for winning for the month of March!

The Boundary Builders are working on campaigns about Healthy Relationships and Consent. These campaigns will be leading up to Junior Prom and Senior Ball. The weekly lessons will focus on topics around setting healthy boundaries in relationships, aspects of a healthy relationship, and consent.

They will have a Spring Fling dance that is open to all grades on the first weekend after Spring Break. She also shared about a program, Happy Hooves. It is a local nonprofit that operates a couple of farms, and specializes in equine therapy, which is miniature horse therapy. They are going to be bringing in some miniature horses, ducks, and goats for the rest of the year to work with some special education students.

In an effort to recognize positive behaviors on campus, staff members have been nominating students for HEROES awards. Students who are nominated are recognized in the Wellness Center and presented with a HEROES certificate and Habit Burger certificate. Their parents are notified of this accomplishment and their name and picture are added to our HEROES hallway in the main office.

For upcoming events, they are still waiting on a date for 6th man. She is excited to cheer on her classmates in their non-basketball players only basketball game against Granada. They are also preparing for Greek Week, which will be held on April 15-19.

Their Youth in Government Day is coming up next Wednesday, and she is really excited to get to participate in it.

She closed by saying, 'Thanks for listening, and today is a great day to be a Cowboy!'

Amanda Dunmeyer, Granada High School (GHS) Student Representative, shared her school update.

She welcomed everyone back from a well-deserved Spring Break, and started off with a joke. 'What is a Matador's favorite sandwich? Bull-only.'

She can say for a majority of the students at Granada, that they all miss the comfort of Spring Break, and not having to worry about all those assignments piling up, and sooner or later, they will be wrapping up their 2023-2024 school year in just a couple of short months.

She recognized Mr. Silvernail. He has taught for over 17 years, with five years at Granada. He teaches civics for Seniors and Freshman Social Science.

There is an outside school ice hockey league that has teams made up of players that go to various high schools in the area and represent their home school. The 'Granada Ice Hockey' team is currently undefeated against six other teams.

Our Spring sports are doing well. Our baseball team is currently 16-1 and ranked 4th in the state. Our boys golf team is on a 4 game winning streak, our boys lacrosse team defeated Cal in an exciting 14-13 game, our softball team is on a 2 game winning streak and our track and field team had some amazing performances at the Granada Distance and Sprint festival.

On Friday, students showed off their music ability at Granada's Got Talent. They all had such an amazing time showing their Matador pride by cheering on the many students that showed off their hidden talents such as singing and performing. They will be holding their Lip Dub Friday the 19th. Lip Dub is where all of the Granada students take pride by wearing black and gold singing and dancing while a camera follows us around school.

She closed by stating, 'That's all for today, stay classy and today is a good day to be a Matador.'

7.0 EMPLOYEE ASSOCIATION REPORTS

7.1 Employee Associations will report on activities

Ms. Aimee Thompson, President of the Livermore Education Association, representing teachers, nurses, counselors, psychologists, speech pathologists and teachers on special assignment commented.

She shared that she noticed a few things while reviewing the Agenda. She noticed that the meeting minutes for the March 30th Special Board Meeting state there was no public comment during item 2.0 comments from the public. She noted that she spoke during that meeting on behalf of members in support of using a search firm to conduct a robust, unbiased search for the next superintendent. She offered to provide those comments if needed.

Secondly, she noticed that the Enrollment and Staffing Report is projecting a decline in enrollment of 252 students for next year. This is a decline of nearly 2%. She shared that it has been repeatedly reported that we have stable enrollment in the District because the change in enrollment is 2% or less. She commented about looking back at historic data and found some interesting things to share. She shared the CalPads enrollment data from 2018-19 school year to the 2022-23 school year showing a decline in enrollment over those 5 years of 791 students - this is 5.8%. The District Enrollment and Staffing Reports from 2019-20 to 2023-24 show a decline in enrollment of 644 students over those 5 years - this is 4.6%. She went on to share that if we add in the projected decline of enrollment for next year it means a decline of 896 students over 6 years. She shared that the data between these two reports do not match, and is probably due to the date the data is pulled being a snapshot. She believes we need to be looking at our enrollment and staffing very carefully. She stated that she is happy to share the multi-year data she has compiled.

This Thursday they will return to the bargaining table for continued discussions of their reopener negotiations. They look forward to productive, collaborative conversations aimed at working together to solve problems and provide the best for students.

She closed by sharing that she and Eileen will be at the Special Board Meeting on April 17th to learn more about the process for selecting the next superintendent. They look forward to supporting the Board in making this very important decision.

Jennifer Advincula, Executive Assistant (EA) to the principal at Granada High School, spoke on behalf of the dedicated executive assistants at the 18 elementary, middle, and high schools. She shared that the Board will be hearing more about this in the days to come, so they felt that it would be very important for the Board to hear it directly from them to better understand where they are coming from.

She acknowledged that Board Members have visited school sites, so they are aware that EAs are the face and heart of the schools. She shared that they work hard to serve students, families, teachers, staff, and administrators. They are not only there for the scraped knees and nosebleeds, but they are there to help manage the day-to-day operations of schools and handle every request and emergency that arise. They are the right hand of their principals, and in some cases, the acting vice principals when their administrators are not on-site. They make sure everyone's needs are met while they monitor their school's budget to ensure that they remain fiscally on target.

She went on to share that it is not a secret to anyone that they have been assigned many additional duties over the years, that they accepted diligently and without complaint because they take pride in the work they do and care about the people they serve and work with. She added that time and time again, when process changes are made, the executive assistants at schools are the people who are called upon to handle new duties. They know this is not the end of them receiving additional responsibilities. Their concern is their ability to serve the community, and morale will diminish.

Their CSEA collective bargaining agreement allows employees to submit a request for reclassification, and they finally decided that it was time that they step forward and advocate for themselves.

She noted that in November of 2023, the Executive Assistants at the District's 18 school sites came together unanimously to submit their request for reclassification, ultimately asking for a mere 5% increase in their compensation for the additional work that has been assigned to them over the years. Among their many additional duties, they brought forward four items for consideration:

- 1. Job postings and HR-related work that was once completely handled by an HR Specialist at a higher level.
- 2. Credentialed stipends that were once handled by Executive Assistants at the district, who are a higher classification.
- 3. Certificates of Insurance that were once handled by the Confidential Executive Assistant to the Assistant Superintendent of Business Services.
- 4. Volunteer approval and management that was once handled by the Confidential Executive Assistant to the Executive Director of Human Resources.

Ms. Advincula shared that they finally presented their case to the Reclassification Committee, which included two District employees and two CSEA members. She added that to their dismay, the Committee was divided, two in favor of reclassification and two opposed, and the Superintendent denied their Reclassification request.

She shared that the 18 Executive Assistants at their school sites feel overlooked and dejected and they decided to appeal their Superintendent's decision.

She shared that they will present their case to the Reclassification Appeal Panel, and the Superintendent will present his recommendation to the Board for approval. The district may point to the Classification and Compensation Study completed last year that seemed to indicate that Executive Assistants to the principal are paid above market. They maintain that the study was flawed, and conducted their own survey by personally contacting Executive Assistants at 10 neighboring school districts. She noted that they learned that the additional duties that they have been assigned over the years are not duties that they perform. The Class & Comp study was flawed because it did not compare apples to apples.

She went on to say that the Reclassification denial was flawed. She shared that the decision should not be based on the rate of our current compensation or about how much other districts pay their employees. She said that it needs to be, per their collective bargaining agreement, about being recognized and compensated for the additional duties that they have been assigned. The District acknowledged that they have been assigned additional duties, but still denied their reclassification.

Ms. Advincula noted that after the appeal process, the Superintendent will present his recommendation to the Board. They hope that on that day, the Board will remember what was shared and will cast a conscionable vote to approve our Reclassification request. They are only requesting a 5% salary increase in recognition and compensation for the additional work they have been doing.

She closed by thanking all for their time.
